



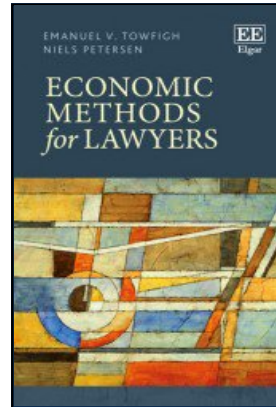
## Economic Methods for Lawyers
